1. Certificate of Insurance in the name of purchaser (for small ship with engine/s of 10 HP or more), valid until the next renewal date of the Certificate of Registry;
2. Last Certificate of Registry issued by Transport Malta;
3. Copy of I.D. card of seller/s, purchaser/s & witness;
4. In cases of a transfer of engine/s only, a Certificate of Survey confirming that the vessel can be equipped with such engine or engines and consequently, will remain seaworthy and fit for its purpose; and
5. If a small ship is registered on a Company/Organisation, a signed declaration/resolution by its director/s and documents attesting the power of such director/s. (e.g. Memorandum and Articles of Association, Statute, etc.)
