BERTHING REGULATIONS 1975

IN terms of the Berthing Regulations 1975, the Director of Ports directs that within one nautical mile radius off the island of Filfla no vessel or boat or any craft may berth or navigate; no person may swim or carry out activities connected with underwater diving and no trawling, trammelling, dropping of anchors and any other activity connected with fishing or otherwise is permitted, unless persons carrying out such activities are in possession of a permit, obtainable from the Department of Ports.

The prohibited zone is within a circle of radius 1.1 nautical miles centres of the following coordinates -- Latitude 35° 47' .37N Longitude 14° 24' .60E.
